## What's New:

- · There are rate changes for the AvMed High Plan and AvMed High with no RX medical plans
- Dependent only coverage will have a rate increase
- If you are currently enrolled in a Medicare Plan and do not wish to make any changes, no further action is needed. Your current plan will continue for the 2023 Plan Year
- Enriched Dental PPO Plan Enhancements:
  - The maximum benefit amount will increase from \$1,500 to \$2,000
  - The Orthodontia lifetime maximum benefit amount will increase from \$1,000 to \$1,300
  - Implants will now be covered at 50% up to the annual maximum benefit amount
  - Night guards for Temporomandibular Joint disfunction (TMJ) will now be covered at 50% up to the annual maximum benefit amount
